



CAMP MUJUK COMMANDING OFFICER'S SUICIDE PREVENTION POLICY



Protecting our Marines and Sailors is one of our top priorities as leaders. The loss of anyone to suicide is senseless, painful, and avoidable. Prevention starts with understanding the warning signs and having a willingness to take immediate action.

If you ever hear someone talk about suicide – always assume they are serious. Never ignore the call for help and never keep it a secret. Get help immediately by informing someone that is in the position to provide assistance. Never leave a person alone who may even be remotely contemplating suicide. Talk to the Marine or Sailor and let them know that you care and you want to help. It is **YOUR** responsibility to ensure the chain of command is notified.

If you are experiencing emotional stress, you will not be judged or thought of as weak by this command. We will take care of you. Do not hesitate to talk to someone. Suicide is never the solution to your problems. Remember that no Marine is a one-man fighting hole – have the courage to ask for help. Do not keep a problem to yourself.

Those Marines and Sailors to your left and right are your brothers and sisters and are willing to help. Resources available to you include the Command Duty Officer, your chain-of-command, the Suicide Prevention Program Coordinator, and the Camp Mujuk Chaplain. Marines can also call the National Suicide Prevention Lifeline at 1-800-273-TALK or Military OneSource at 1-800-342-9647, 24-hours / 7-days a week.

CAMP MUJUK COMMANDING OFFICER'S SEXUAL ASSAULT PREVENTION AND RESPONSE POLICY



"To eliminate unprofessional behavior within the Marine Corps that wrongly sets conditions that enable sexual assault; to ensure due process for offenders; to provide appropriate and sensitive care for victims; and to develop programs that reduce the negative effect sexual assault has on the combat readiness of Marines, Sailors and the units or commands to which they belong."

-MCO 1752.5B Sexual Assault Prevention and Response (SAPR) Program

Sexual assault is a crime that is not unique to any gender, race, or age. Sexual assault is defined as intentional sexual contact, characterized by the use of force, physical threat of force or abuse of authority; or when the victim does not or cannot consent. All leaders and members of the Camp Mujuk team will become familiar and comply with MCO 1752.5B *Sexual Assault Prevention and Response (SAPR) Program*.

I will not tolerate sexual assault in any form, against any individual. Failure to report or ignoring sexual assault incidents will irreparably damage unit cohesion and has long lasting consequences to the individuals effected.

Victims will be treated with sensitivity, decency, and respect, and will receive appropriate medical, emotional, psychological, legal, and social services. Care will be given to ensure the identity of a victim is released only to those who have a need to know (unit commander, PMO, NCIS). Victim safety is paramount at all times. Victims who chose to make a restricted report in accordance with MCO 1752.5B will have that choice honored to the fullest extent. Victims who have the courage to report must feel confident their personal safety and privacy will be protected and they will not be re-victimized by the organization. Marines, Sailors and Civilians who are sexually assaulted are physically, mentally, and emotionally traumatized. They deserve to be treated with sensitivity and care.

Individuals in supervisory roles will ensure compliance with MCO 1752.5B and receive annual refresher training. Marine Corps Community Services (Marine and Family Programs), the Sexual Assault Response Coordinator (SARC) and the Uniformed Victim Advocate (UVA), will assist in SAPR training responsibilities and will assist victims.
