
Subj: OFF-LIMITS ORDER FOR BERNARD'S GARAGE

Ref: (a) MCBJO 5420.2A

1. Purpose. To place Bernard's Garage off-limits to Status of Forces Agreement (SOFA) personnel.
2. Background. This command has received credible information that Bernard's Garage utilizes unfair commercial practices. SOFA personnel have paid thousands of dollars for the purchase of vehicles, but have received nothing in exchange for their funds. I consider the reported activities and practices a threat to the good order and discipline of our military and civilian communities.
3. Action. Pursuant to reference (a), effective immediately, Bernard's Garage located at 1163 Aza-Noborikawa, Okinawa City, Japan is off-limits. See enclosure (1) for location map of Bernard's Garage.
4. Applicability. This Bulletin is applicable to all SOFA personnel attached to or accompanying III Marine Expeditionary Force/Marine Corps Bases Japan personnel. This includes all military members, civilian personnel (including contractors), and all dependents. This Bulletin constitutes a general order, and is punitive in nature. This Bulletin applies to personnel attached permanently or in a Temporary Additional Duty status, and will remain in effect until superseded or cancelled. Penalties for violations of this Bulletin include the full range of statutory and regulatory sanctions for civilian and military personnel. The sole exception to this Bulletin is personnel entering Bernard's Garage in the performance of their official duties.

5. Dissemination. Subordinate commanders are directed to ensure that this order receives the widest possible dissemination.


