

Responsible for overall use and care of tools, equipment and supplies required to complete assigned duties. Mentors, trains, and provides guidance on professional and personal development to assigned personnel. Serves as liaison between the Cook Foreman A and Master Labor Contract (MLC) subordinates pertaining to personnel (i.e. leave status (Sick/Pregnancy Leave/Child Care Leave/Family Care Leave, etc., manpower related information, accident/mishap reports, MLC health status, etc.) in a timely manner. When not exercising their responsibilities assigned in above task, will perform the same duties and responsibility of Mess Attendant (Heavy), BWT-2-3 and Food Service Worker, BWT-2-2 etc.		
Essential Duty: Mess Halls will normally remain open until Tropical Cyclone of Readiness (TCCOR) – 1 Caution (1C). Essential employees may be required to stay through TCCOR-1C to perform tasks listed above.
