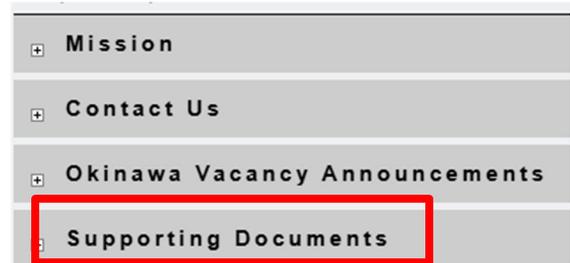

① Hard copy submission (履歴書投函)

<p>Summary of duties:</p> <p>Under supervision of a Staff Non-Commissioned Officer and Japanese Security Guard supervisor, perform any one or more of a variety of guard duties at the United States Marine Corps Base, Okinawa, Japan. Stand guard at designated entrance/exit gates and control traffic of military or civilian personnel and vehicles entering/exiting USMC installations. Check documents, personnel badges, identification and passes, property removal authorizations granting or denying entrance or exit as indicated. Detain unauthorized visitors, take appropriate minor corrective action or report other incidents to superiors for instruction and await arrival of proper personnel to correct the irregularity detected. When a Military Police Alert (MPA) is issued, the Japanese Security Guard stop individuals or vehicles to conduct identification check. Once suspicious individuals or vehicles are found through aforementioned process, the Japanese Security Guard will order the driver to pull his/her vehicle over to the side, seize such identification and notify MP Desk immediately. If the Japanese Police are in "Hot Pursuit" of flagrant offender, and access through a gate, the Japanese Security Guard will notify the MP desk immediately. Verify destination of visitors as required, make appropriate telephone clearance and provide instructions for reaching organizations and personnel. Issue visitor permits after obtaining clearance from individual or organization involved. As required, maintain logs and other records to identify persons, check personnel, parcels or vehicles to prevent unauthorized removal of shipyards etc., involving unauthorized entry. Detect such conditions as fire, unlocked entryways or equipment left in operation and other similar disorders. Duties require understanding of an ability to follow routine security procedures in which instruction is supplied periodically. Perform other related or incidental duties as assigned.</p> <p>This is a Mission Essential Position.</p>
