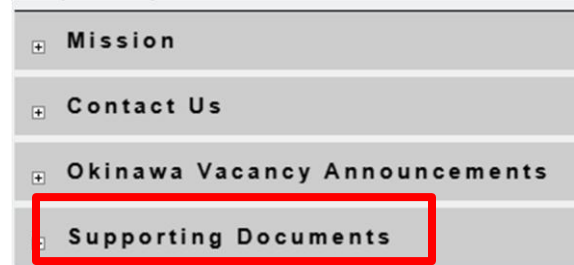

Task List: Accomplishes necessary site survey, task assessment, scope, and lay-out work which may be from blueprints, sketches, or general instructions and decides welding processes best suited for assigned task(s). Operates Shielded Metal Arc Welder, Gas Metal Arc Welder, Gas Tungsten Arc Welder. Performs both acetylene torch and electric arc welding on a variety of metals and their alloys such as copper, brass, aluminum, steel iron, and stainless steel in sheet, bar, rod, and tubing form using acetylene welding equipment, electric welding generator, welding rods, special and common tools, and precision measuring devices to unite metallic parts by fusion so that they form an integrated whole. Cuts metals using oxyacetylene torch and/or by other job related tools/means. Welds metal parts together by melting and adding metal at joints or fractures. Fabricates, builds, assembles, installs, hangs/affixes, and repair-welds on/with metal objects such as high pressure tanks, carts, overhead pipes and ducts, structural steel, hand rails, gates, stands, and other special projects. Performs various corrosion control tasks and applies appropriate paint coatings over welds and corrosion controlled surfaces. Welds in any position, overhead, vertical, flat, indoor and outdoor. Operates shop machinery such as but not limited to: drill press, sabre saw, grinders, sanders, shears, punch and coper, brake, shearer, etc. May also operate seam welding and butt welding machines. Maintains equipment, tools, supplies, simple records and clean working environment. Appropriate licensing requirements must be met. Performs other related or incidental duties as assigned. Operates commercial vehicles (eg, small truck and small crane) up to 2 ton daily. May operate heavy vehicle and UNIC(up to 7 ton) as required. Performs other incidental duties as assigned.

Qualification Requirements 資格条件

1. Must have Arc Welder License. アーク溶接工の資格があること。
2. Must have working experience as a Sheet Metal Worker. 板金工としての実務経験があること。
3. Must have or ability to obtain and maintain crane (UNIC) license, rigging license, and Heavy Vehicle license (7 t).

4. Able to accomplish welding work independently based on work orders, blueprints, specifications, and accepted building practices. 作業指示書、設計図、仕様書、および一般的な建築慣行に基づいて、板金接作業を単独で遂行できる事
5. Must have a valid driver's license and able to obtain Government Owned Vehicle (GOV) license. 運転免許を有し、公用車 (GOV) の免許を取得できること。

9. The work involves prolonged standing, bending, stooping, physical exertion, kneeling and other uncomfortable and tiring positions. Exposed to sawdust, grease, oil, metal shavings, and flying chips etc. The worker may have a risk of falling from scaffolds or ladder, injuries from powered and hand tools.
