

SECTION V - STATEMENT OF RESPONSIBILITY

1. I understand that my vehicle must be registered in my name for at least 120 days before re-registration, unless I PCS/DEROS. I also understand that I am authorized no more than one four-wheeled passenger vehicle and one motorcycle per properly licensed, on-island family member. Additionally, it is my responsibility to ensure that my vehicle is either properly re-inspected or de-registered before its Japanese inspection expiration. Japanese law requires re-inspection within 30 days before expiration.

Your Japanese inspection expiration date is 9/10/2017

2. I am aware that MCO 5110.1C/AFR 125-14/AR190-5/OPNAV 11200.5C and the installation traffic code provide for the removal and temporary impoundment of privately owned motor vehicles that are parked illegally for unreasonable periods, interfering with military operations, creating a safety hazard, disabled by incident, left unattended in a restricted or controlled area, or abandoned. I agree to reimburse the United States for the cost of towing and storage should my motor vehicle, because of such circumstances, be removed and impounded.

3. I do hereby expressly agree and understand that in the event I depart Japan due to PCS/DEROS orders, retirement, separation, or otherwise permanently leave without de-registering my vehicle or lawfully providing for de-registration by means of Special Power of Attorney IAW MARCORBASE/JAPAN Order P11240.1, I transfer all rights, title, and interests in the vehicle, and personal property located therein, to the United States Government for disposal as deemed appropriate in the sole discretion of the United States, and I release and discharge the United States Government and its agents from any and all claims and demands whatsoever by me arising out of the impoundment and disposition of the vehicle registered to me. I understand that if any liens on the vehicle exist at the time of my permanent departure that I am not relieved of my financial responsibility to the lien holder for that claim. I further understand that if I depart as described above, I will not be entitled to be notified under Title 10, United States Code, section 2575 that the vehicle registered to me has been impounded for ultimate disposal by the United States.

- AUTHORITY:** Title 10, U.S.C. 8013, Commands: Territorial and Organization, E.O. 9397, Numbering System for Federal Accounts relating to individual persons.
- PRINCIPLE PURPOSE(S):** Registration of POV. Form is used to record pertinent information data on individual and technical data on POV being registered.
- ROUTINE USES:** Used to record vehicle description, ownership, source of procurement, liens involved, and acknowledgement of some POV procedures in Japan. This record is used to monitor vehicles registered in Okinawa, Japan.
- DISCLOSURE:** Voluntary; however, failure to provide information will result in the individual being unable to register his/her POV.
