- 1. <u>Situation</u>. In accordance with the 36th Commandant of the Marine Corps' (CMC) Planning Guidance, specifically his emphasis upon Setvice-wide conservation of energy resources, every Commander is accountable for leading energy reduction efforts for operations under his or her responsibility. In fulfillment of this goal, MARADMIN 114/15 establishes CMC's intent to educate and directly involve installation tenant commands in the application of and adherence to best practices intended to promote energy efficiency and conservation within their buildings and facilities.
- 2. <u>Mission</u>. Each battalion/squadron-level and higher Marine Corps unit permanently assigned to III Marine Expeditionary Force (MEF) and Marine Corps Installations Pacific (MCIPAC) on Okinawa will ensure the appointment and training of a Unit Energy Manager (UEM) per reference (a).

3. Execution

- a. Commander's Intent and Concept of Operations
- (1) Commander's Intent. Ensure all designated-level camp and tenant commands comply with requirements established in reference (a).

(2) Concept of Operations

- (a) All battalion/squadron-level and higher III MEF/MCIPAC commands permanently assigned on Okinawa will appoint a minimum of one UEM per unit organization per camp. Any one unit geographically dispersed across two or more camps will be required to appoint a UEM per camp occupied.
- (b) Appointment of UEMs will be reported through the respective Camp Operations organizations supporting the tenant commards, e.g. 9th Engineer Support Battalion will report UEM appointment to Camp Hansen Camp Operations. Points of Contact for each Camp Service organization are listed

in paragraph 4 of this Letter of Instruction (LOI).

(c) Commanders will direct their UEMs to MCIPA(-facilitated training in accordance with the training schedule contained in enclosure (1) of this LOI. Following training, UEMs will manage their respective Unit Energy Program for all buildings and facilities assigned to their unit.

- (c) Report completion of UEM training to MCICC1 per reference (a) NLT 23 May 2015.
- (2) Camp Commanders (Camp Schwab, Camp Courtney, Cimp Hansen, Camp Foster, Camp Kinser)
- (a) Direct subordinate battalion/squadron-leve. and higher unit organizations to appoint a minimum of one UEM.
- (b) Designate a minimum of one UEM at the Camp Operations level to promulgate program information to and consolidate information from tenant organization UEMs occupying the camp.
- (c) Camp Operations-level UEMs will serve as the connector between the MCB Camp Butler Installation Energy Manager (IEM) and the UEMs assigned to the individual commands.
- (d) Report completion of UEM appointments for all designatedlevel unit organizations assigned to the camp to G-F Operations NLT 29 April 2015.
- (e) Ensure appointed UEMs attend MCIPAC facilitated training per the schedule contained in enclosure (1).

(3) CO, Marine Corps Air Station Futenma

- (a) Direct subordinate battalion/squadron-level and higher unit organizations to appoint a minimum of one UEM.
- (b) Designate a minimum of one UEM at the Installation Logistics and Services (ILS) level to promulgate program information to and consolidate information from tenant organization UEMs occupying the air station.

- (e) Ensure appointed UEMs attend MCIPAC facili ated training IAW the schedule contained in enclosure (1).
- (4) III MEF Major Subordinate Commands (3d Marine) ivision, 1st
 Marine Aircraft Wing, 3d Marine Logistics Group, and 3d Marine Expeditionary
 Brigade)
