Notes:

- Confinement Orders must be the ORIGINAL copy. This includes the Confining Officer's signature along with the Medical Officer's signature, signatures can be digital or "wet". To confine enlisted personnel, any Commissioned Officer (CWO2 or higher) can sign the Confining Officer's block. Officers can only be directed into pretrial confinement by their Battalion Commander or higher. The medical block can only be signed off by a Medical Officer, Nurse Practitioner, or Physician's Assistant.
- It is requested that commands have new confinements tested for COVID-19 on the same day that the confinement physical is completed.
