- 1. Situation. To provide amplifying quidance concerning the Commander, United States Navy Region/Commander, United States Naval Forces, Korea off-limits area notification.
- Mission. Per reference (a), effective immediately, the area 2. in Busan known as "Texas Street" is off-limits from 1700 to 0500 to all Marines permanently or temporarily assigned to United States Marine Corps Forces, Korea. The 0100 to 0500 Korea-wide curfew promulgated in reference (b) remains in effect.

3. Execution

Commander's Intent and Concept of Operations

(1) Commander's Intent

- (a) This policy is enacted to protect the well-being and the safety of Marines training in the area of Busan and to maintain our strong alliance with the Republic of Korea. has been an increase in criminal behavior, to include nightclub owners condoning or explicitly offering prostitution, overserving alcohol, and non-U.S., non-Korean foreign nationals attempting to start fights. All of these events have taken place in nightclubs in the vicinity of Texas Street after 1700. These incidents are inconsistent with our efforts to combat trafficking in persons and are in conflict with our core values.
- (2) Concept of Operations. Texas Street is defined as the area west of Busan station, shaped as a rectangle, bound by the following four streets: Jungang-Daero, Jungang-Daero 179 Beon-Gil, ChoryangJung-Ro, and Jungang-Daero 231 Beon-Gil. Commanding Officers and Officers-in-Charge will conduct routine

Subj: OFF-LIMITS AREA NOTIFICATION - TEXAS STREET, BUSAN patrol of the area depicted in enclosure (1) to ensure compliance of this policy.

c. Tasks

- (1) G-1. Disseminate a copy of this policy to all Marines temporarily and permanently assigned to Korea.
- (2) G-3. Ensure all units conducting training in the vicinity of Busan is provide a copy of this policy.

4. Administration and Logistics

a. A detailed colored Map will be maintained on the U.S. Marine Corps Forces, Korea SharePoint site.
